Regulatory Statement

Hazard Statements

The WD-40 Company Limited product range each has a CLP (Regulation (EC) No. 1272/2008) hazard product label bearing the relevant hazard statements describing the nature and severity of the hazards of the mixture (see CLP Article 21). The correct wording of the hazard statements as it must appear on the label is given in Annex III to CLP, in all EU languages.

Aerosols – H304 Labelling Exemption

Some aerosol products are classified as H304 (Asp. Tox 1; May be fatal if swallowed) in section 2.1 of the safety data sheet (SDS), but not in section 2.2 (label elements). This is due to section 1.3.3. from Annex I (classification and labelling requirements for hazardous substances and mixtures) of Regulation (EC) 1272/2008 (CLP), which applies to aerosol products, and therefore no labelling regarding this hazard, such as the GHS08 pictogram regarding aspiration hazards, is needed:

Extract from CLP Regulation - 1.3.3. Aerosols and containers fitted with a sealed spray attachment and containing substances or mixtures classified as presenting an aspiration hazard

With regard to the application of section 3.10.4, substances or mixtures classified in accordance with the criteria of sections 3.10.2 and 3.10.3 need not be labelled for this hazard when placed on the market in aerosol containers or in containers fitted with a sealed spray attachment.

Precautionary Statements

The WD-40 Company Limited product range each has a CLP hazard product label bearing the relevant precautionary statements giving advice on measures to prevent or minimise adverse effects to human health or the environment arising from the hazards of the mixture (see CLP Article 22).

Classification of substances and mixtures
